FROM YOUR EDITOR

The impact of the invention, development, and adoption of new and improved electronic devices in the modern world is abundantly obvious, (in approximate correspondence with age and/or maturity). Almost any adult is capable of generating a list of more than a dozen electronic devices that were not commercially available "when I was a kid".

As with all technological developments, however, there are the unwanted side effects, ranging from merely annoying to the nefarious or outright illegal. For instance, legislation banning the use of handheld text devices while driving has been passed in 39 states, the District of Columbia and Guam. Moreover, reports of ID theft have become a common item in news media, especially when companies the size of Amazon, Sony, or even the federal government report a hacking of thousands of data entries in their internal files. But even on the individual level, many uninformed users of file-sharing programs (Peer-to-Peer or P2P) have learned that important personal information, including credit card and banking links, have been stolen by the use of such programs.

For many years various consumer groups have called for the federal government to issue a National Identification Card. The Social Security Administration has consistently stated that the Social Security Number is not to be used for identification purposes. But what is usually required as proof when applying for a driver's license or for voting registration, or when you start a new job? The opposition to a National ID has usually stemmed from "high costs" or "privacy" considerations. In rebuttal, the proponents of the National ID point to the jump in cost of a US Passport that occurred as the growth of terrorism. Similarly, it is a growing practice of the medical community to store patient data electronically outside of the actual physician's office.

Given the amount of data that can be encrypted and stored on a credit card, and the number of identification verification items that are available, ranging from the classic - age, height, weight, hair color, gender, place of birth, and yes, fingerprints, to the exotic - retina scans, DNA, blood type, multi-point facial recognition, and so on - it looks like a multi-billion dollar investment opportunity for a bold entrepreneur or a government that needs some high tech program to replace NASA.
